## REQUEST FOR PROPOSAL (RFP)

## **INVITATION OF BIDS FOR BARBER SERVICES**

- 1. Bids in sealed cover are invited for Barber Services as listed in part II RFP. Please super scribe the above mentioned Title, RFP number and date of opening of the bids on the sealed cover to avoid the bid being declared invalid.

- 3. This RFP is divided into five parts as follows:-
  - (a) <u>Part I-</u> Contains general information and instruction for the Bidders about the RFP such as the time, place of submission and opening of tenders, Validity period, Mode of tenders etc.
  - (b) <u>Part II-</u> Contains essential details of the items/services required, such as the Schedule of Requirements (SOR), Technical specifications, Delivery and Consignee details.
  - (c) <u>Part III –</u> Contains Standard Conditions of RFP, which will form part of the Contract with the successful Bidder.
  - (d) <u>Part IV –</u> Contains special Conditions applicable to this RFP and which will also form part of the contract with the successful Bidder.
  - (e) Part V Contains Evaluation Criteria and Format for Price Bids.
- 4. This RFP is being issued with no financial commitment and the Buyer reserves the right to Change or vary any part thereof at any stage. Buyer also reserves the right to withdraw the RFP, Should it become necessary at any stage.

## **PART I- GENERAL INFORMATION**

### 1. Last date and time for depositing the Bids (DDMMYYY): 25 Feb 2025

The sealed bid should be deposited/reach by the due date and time. The responsibility to ensure this lies with the Bidder.

2. <u>Manner of depositing the Bids</u>: Sealed Bids should be either dropped in the Tender Box at Sainik School Jhansi, or sent by registered post at the address given above so as to reach by the due date and time. Late tenders will not be considered. No responsibility will be taken for postal delay or non –delivery /non receipt of Bid documents. Bids sent by FAX or e-mail will not be considered (unless they have been specifically called for by these modes due to urgency).

## 3. Time and date for opening of Bids 27 Feb 2025 1100 hrs

(If due to any exigency, the due date for opening of the bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Buyer).

- 4. <u>Location of the tender Box:</u> Sainik School Jhansi (Only those Bids that are found in tender box will be opened or received by registered post. Bids dropped in the wrong Tender Box or received by after **25 Feb 2025** will be rendered invalid).
- 5. Place of opening of the Bids: At the office of Adm Officer. The Bidders may depute their representative, duly authorized in writing, to attend of Bids on the due date and time Rates and important commercial/technical clauses quoted by all Bidders will be read out in the presence of the representatives of all the Bidders. This event will not be postponed due to non-presence of your representative.
- 6. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time.
- 7. **Forwarding of Bids:** Bids should be forwarded by Bidders under their original memo / letter pad inter alia furnishing all details mentioned in **Appendix "A".**
- 8. <u>Clarification regarding contents of the RFP:</u> A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarification sought not later than 7 (Seven) days prior to the date of the Bids. Copies of the query and clarification by the purchaser will be sent to all prospective bidders who have received the bidding documents.

- 9. <u>Modification and Withdrawal of Bids:</u> No bid shall be modified after submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the period of bid validity specified. Withdrawal of a bid during this period will result in Bidder's forfeiture of bid security.
- 10. <u>Clarification regarding contents of the Bids:</u> During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post- bid clarification on the initiative of the bidder will be entertained.
- 11. <u>Rejection of Bids:</u> Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection. Conditional tender will be rejected.
- 12. <u>Unwillingness to quote:</u> Bidders unwilling to quote should ensure that intimation to this effect reaches before the due date and time of opening of the Bid, failing which the defaulting Bidder may be delisted for the given range of items as mentioned in this RFP.
- 13. <u>Validity of Bids:</u> The Bids should remain valid till 45 days beyond the last date of submission of the Bids.

## 14. Cost of Tender Form: NIL

- 15. Earnest Money Deposit: Bidders are required to submit Earnest Money Deposit (EMD) for amount of ₹9600 /- (Rupees Nine Thousand Six Hundred, 02 % of estimated value of the bid) in the form of DD only payable to Principal, Sainik School Jhansi along with their bids. The EMD may be submitted in the form of account payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the public sector banks or a private sector bank authorized to conduct government business per Form Defence Procurement Manual DPM -16. EMD is to remain valid for a period of forty five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be submitted by those Bidder's who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD or MoD itself. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity of their tender
- 16. <u>Filling of Tender Documents:</u> Filling of all the relevant points of tender documents is mandatory by the Tenderer. Anything missing on the document part will be treated as cancel of complete tender document. Tenderer will not have any right to claim on the subject issue.
- 17. <u>Credential of Tenderer:</u> Tenderer is supposed to submit the all relevant credential document along with the tender form.

## PART II-ESSENTIAL DETAILS OF ITEMS/SERVICES

- <u>1.</u> Schedule of Requirements: Principal, Sainik School Jhansi invites bids from experienced professionals for provisioning of services of a Barber, at Sainik School Jhansi:-
  - (a)Hair Cutting
  - (b)Shaving

## 2. Terms & Conditions:-

- (a) The barber will visit the school premises for cutting the hair of cadet's minimum twice in month or as per requirement.
- (b) Contractor will responsible to place the following items in school in Serviceable condition:
  - i. Electric Machine for Hair cut 2
  - ii. Manual Hair Cutting machine 2
  - iii. Antiseptic 1 Bottle
  - iv. Talc Powder 1
  - v. Good wrapping cloth-2
  - vi. Scissor for Hair Cut 2
  - vii. Comb Small teeth 2
  - viii. Comb large teeth 2
  - ix. Hand water Fountain 1
  - x. Apron for Barber- 2
  - xi. antiseptic soap with soap case 1
- (c) Minimum two barbers should be on work at a time.
- (d) Proper hygiene and sanitation should be maintained.
- (e) Ensure that equipment's are periodically inspected from the School.
- (f) The school will provide accommodation only. Furniture (chair, Front/Back mirrors, Tables) and proper equipments are to be brought by the Tenderer.
- (g) Two hair cut must be provided to each cadet in a month.
- (h) Timing
  - i. Working Days 1400 hrs to 1730 hrs
  - ii. Sunday/ Holidays 0800 hrs to 1300 hrs & 1400 hrs to 1730 hrs
- (i) Proper record of haircuts of all cadets will be maintained and submitted along with monthly bill duly signed by the respective cadets.

Vendor Signature with rubber stamp

- The price quoted by the Bidder should be inclusive of GST and all other taxes applicable. In the absence of detailed stipulation, it will be presumed that the prices include all such charges and no claim for the same will be entertained. The price quote should be valid for 01 years (Refer Para-II, Sr. No.1)
- (j) Super scribe the Title, RFP number and date of opening of the bids on the sealed cover to avoid the bid being declared invalid.

- (k) Clear details of items are mentioned in the schedule of requirements.
- (I) No revision of rates will be permitted once the contract is entered into.
- (m) Service supplied against the supply order issued by the Principal, Sainik School Jhansi (UP) will be inspected on receipt and items found damaged or inferior items will have to be replaced by the supplier and cost of delivery will be borne by the supplier.
- (n) The service will be ordered anytime throughout the period of contract and the supplier will execute the order as per the terms and conditions.
- (o) While quoting the prices, tenderers must bear in mind that substandard/adulterated items will not be accepted and therefore prices for genuine quality of items should only be quoted. The rates quoted should be inclusive of all charges at net supply rates at Sainik School Jhansi (UP). Price of each item should be legibly written in figures. Any correction/alteration made in the tender form without authentication will not be accepted.

## PART III - STANDARD CONDITIONS OF RFP

- 1. **Legal Jurisdiction**: All disputes will be subject to Jhansi, UP jurisdiction only.
- 2. **Liquidated damages**: In the event of the seller's failure to submit the Bonds, Guarantees and Documents, supply the stores/goods and conduct trials, installation of equipment, training etc. as specified in this Supply Order, the Buyer may, at his discretion, withhold any payment until the completion of the Supply Order. The Buyer may also deduct from the Seller as agreed, Liquidated Damages to the sum of 0.5% of the Supply Order price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.
- 3. Performance Bank Guarantee: The successful bidder will deposit an amount equal to 3 percent of contract value on award of contract. PBG should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. EMD should be through Bank Draft/Account Payee Demand Draft/Bankers Cheque drawn in favour of Principal Sainik School Jhansi payable at State Bank of India, Bundelkhand University Jhansi (IFSC SBIN0003808, Branch Code No.003808)
- 4. **Termination of the Contract:** The Buyer shall have the right to terminate this contract in part or infull in any the following cases:-
  - (a) The delivery of the service is delayed for not attributable to Force Majeure for more than (01 month) after the scheduled date of delivery.
  - (b) The Seller is declared bankrupt or becomes insolvent.
  - (c) The delivery of service is delayed due to causes of Force Majeure by more than 01 month.
  - (d) The Buyer has noticed that the Seller has utilized the services of any (Page  $\mathbf{5} \text{ of } 10 \, \mathbf{10}$

Indian/foreign agent ingetting this Supply Order and paid any commission to such individual/company etc.

- (e) As per decision of the Arbitration Tribunal.
- (f) Continuous bad performance (for any two months in a semester) will result in termination of the contract.
- (g) Any other reason as deemed fit by the school administration.
- 5. **Access to Books of Accounts:** In case it is found to the satisfaction of the Buyer that the Sellerhas engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Seller, on a specific request of the Buyer, shall provide necessary information/inspection of the relevant financial documents/information.
- 6. **Non-disclosure of Contract documents:** Except with the written consent of the Buyer/ Seller, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample orinformation thereof to any third party.
- 7. **Transfer and Sub-letting:** The Seller has no right to give, bargain, sell, assign or sublet or Otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.
- 8. **Notices:** Any notice required or permitted by Supply Order shall be written in the English Language and may be delivered personally or may be sent by FAX or registered pre-paid mail/ airmail, addressed to the last known address of the party to whom it is sent.

#### 9. Taxes and Duties:

- (i) The price quoted by the Bidder should be inclusive of GST and all other taxes applicable. In the absence of detailed stipulation, it will be presumed that the prices include all such charges and no claim for the same will be entertained.
- (ii) If reimbursement of any Duty/Tax is intended as extra over the quoted prices, the Bidder must specifically say so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duty/tax will be entrained after the opening of tenders.
- (iii) If a Bidder is exempted from payment of any duty/tax up to any value of supplies from them, he should clearly state that no such duty/tax will be charged by him up to the limit of exemption which he may have. If any concession is available in regard to rate/quantum of any Duty/tax, it should be brought out clearly. Stipulations like, the said duty/tax was presently not applicable but the same will be charged if it becomes liveable later on, will not be accepted unless in such cases it is clearly stated by a Bidder that such duty/tax will not be charged by him even if the same becomes applicable later on. In respect of the Bidders, who fail to comply with this requirement, their quoted prices shall be loaded with the quantum of such duty/tax which is normally applicable on the item in question for the purpose of comparing their prices with other Bidders.
- iv) Any change in any duty/tax upward/downward as a result of any statutory variation in excise taking place within contract terms shall be allowed to the extent of actual quantum of such duty/tax paid by the supplier. Similarly, in case of downward revision in any duty/tax, the actual quantum of reduction of such duty/tax shall be reimbursed to the Buyer by the Seller. All such adjustments shall include all reliefs, exemptions, rebates, concession etc. if any obtained by the Seller.

- 10. **Inspection of Items & Work:** The items being supplied and works being carried out will be inspected by a board of members of Sainik School Jhansi as nominated, on behalf of the Principal. A joint inspection will be carried out on completion of the work and works completion certificate needs to be issued by the Board for processing of payment.
- 11. **Payment Terms:** Standard Payment terms, as indicated below, will be incorporated in the Rate Contracts:-
  - (a) It is mandatory for the Bidders to indicate their bank account numbers with IFS Code and other relevant payment details so that payments could be made through NEFT/ Cheque / Bank Transfer / ebanking. The applicable bank charges will be borne by the vendor.
  - (b) 100 % against post inspection delivery at Sainik School Jhansi.
  - (c) The vendor has to submit two copies of Pre-receipted (signature as received payment on bill with Rs 1/- revenue stamp) Invoice/bill.
  - (d) As far as possible, payment will be effected by the paying authority within 30 working days from the date of receipt of bill. Consolidated observations, if any should be forwarded within 15 working days by paying authority to the CFA.

## PART IV - SPECIAL CONDITIONS OF RFP

- 1. **Transportation:** Barber will bear the costs necessary to bring the services to Sainik School Jhansi.
- 2. **Inspection Authority.** The Inspection will be carried out by representative of Principal, Sainik School, Jhansi at the Barber Shop every fortnight. The mode of Inspection will be Departmental Inspection / User Inspection / Joint Inspection / Self-certification.
- 3. Every page of the RFP should be signed (full signature) and rubber stamped by the bidder. It should also be signed wherever there is overwriting and cutting. All the Appendices of the RFP will be completed neatly in English language only.
- 4. **Paying Authority:** Principal, Sainik School Jhansi.
- 5. Specification: As per Schedule of Requirement.

## PART V - EVALUATION CRITERIA & PRICE BID ISSUES

- 1. **Evaluation Criteria**. The broad guidelines for evaluation of Bids will be as follows:
  - a. A demand draft of BID Earnest money (EMD) in favour of Principal "Sainik School Jhansi" must be attached.
  - b. Copy of GST, pan card and Aadhar Card enclosed.
  - c. Character certificate recently issued by DC / Superintendent of Police
  - d. Experience certificate for the corresponding items.
  - e. Self-attested along with stamp at all pages of submitted document is mandatory.
- 2. **Price Bid Format.** Bidders are required to fill up the Price Bid format paced as Appendix "B" correctly with full details.
